

Report of School Closure and Report of School Re-Opening

Part b of Education Law §15 and [Circ Reg 155.17\(f\)](#), each charter school, county board of cooperative educational services (BOCES) and local educational agency, the charter school district of the City of New York and each charter school shall file the Report of School Closure and Report of School Re-Opening with the State Department of Education. The Report of School Closure and Report of School Re-Opening shall be filed by the charter school, BOCES or local educational agency on or before the date specified in the Report of School Closure and Report of School Re-Opening.

Part 155.17(f) of the Regulations of the State Education Department
relating to the closure of schools

The Report of School Closure shall be prepared by the Chief Executive Officer of the LEA (school district, BOCES, or charter school) and shall be submitted to the State Education Department.

1. On the [NYSED BasPal](#);
2. On the LEA's website;
3. Emailly SEDDAS email address;
4. Under the heading "MyAccount" on the NYSED MyAccount and Vedo Performance System;
5. On the "School Closure" page;
6. In the BOCES or the "Report of School Closure" form, which requires the following information:

- school(s) that were closed
- the date of closure and anticipated duration of closure (if known)
- the reason for closure, including any relevant documents, such as a closure order from a county Department of Health
- date that notification regarding the closure was made to the BOCES District Superintendent (if applicable)

When the information is submitted to the State Education Department, the Report of School Closure shall be made available to the public.
